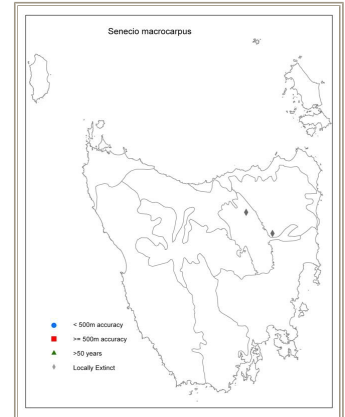

- Flowers are required to confirm the identity of this erect or sprawling shrub from the daisy family. Plants on mainland Australia flower from September to November, and on occasion in March and April. The only Tasmanian records are from October and December in the mid 1800s.
- Senecio macrocarpus* is presumed extinct in Tasmania, having been collected from the north of the State including the South Esk River. In Victoria, the species occurs in basalt grasslands and grassy woodlands.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
