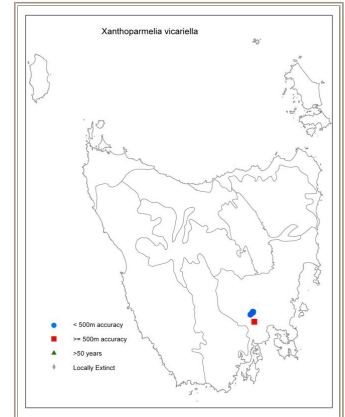

- This foliose lichen can be identified at any time of the year, although expert confirmation of the identity of suspected new populations may be required.
- This species is known only from the Southern Midlands where it occurs on dolerite and basalt boulders in dry sclerophyll woodland and native grassland.

**Permit:** A permit is required under the Tasmanian *Threatened Species Protection Act 1995* to 'take' (which includes kill, injure, catch, damage, destroy and collect), keep, trade in or process any specimen or products of a listed species. Additional permits may also be required under other Acts or regulations to take, disturb or interfere with any form of wildlife or its products, (e.g. dens, nests, bones). This may also depend on the tenure of the land and other agreements relating to its management.
